

The Renovation Room Membership Agreement (2025 Edition)

This Membership Agreement (“Agreement”) is entered into by and between **The Renovation Room, LLC** (“The Renovation Room,” “we,” “us,” or “our”) and the registering contractor, business, or professional (“Member,” “you,” or “your”).

By completing this registration, the Member acknowledges that this is a **paid membership** and agrees to be legally bound by the following terms and conditions.

1. Membership Levels, Qualifications, Dues & Fees

- Members are accepted according to their class of membership (Contractor or Professional).
 - Contractor businesses providing construction or trade services must join under the **Contractor Membership** rate.
 - Membership dues are billed monthly or annually and are **non-refundable** once access or services have begun.
 - Dues may renew automatically unless canceled prior to renewal.
 - Additional fees may apply for optional services, events, or premium access.

2. Term & Termination

(a) Term: Membership begins on the submission date and renews automatically unless canceled in the web portal or in writing.

(b) Termination for Cause: We may terminate membership for violation of this Agreement, unethical conduct, or nonpayment. No refunds will be issued.

(c) Termination by Member: You may cancel at any time; however, payments already made are non-refundable.

(d) Effect of Termination: Upon cancellation, access to The Renovation Room platforms—including the private Facebook Group—will be revoked.

(e) Grandfather Rates: Reduced “grandfather” pricing remains valid only while membership is active. Lapsed or canceled members must rejoin at the current rate.

3. Conduct & Professional Standards

Members agree to:

- Maintain valid business licenses and insurance.
- Operate ethically, lawfully, and professionally.
- Avoid fraud, misrepresentation, or unprofessional behavior.

Bad Business Clause: Repeated complaints, unethical practices, or dishonesty may result in immediate suspension or termination.

Rejoining Under a New Name: Attempting to rejoin under a different entity to avoid disciplinary action will result in permanent denial.

4. Confidentiality & Privacy

Project leads, client data, and internal communications are proprietary to The Renovation Room. Members shall not share or distribute this information to non-members. All personal data will be handled per our Privacy Policy.

5. Dispute Resolution

Members agree first to attempt informal resolution through The Renovation Room. Unresolved disputes shall be settled by **binding arbitration in the State of Illinois** under the **American Arbitration Association** rules. Each party bears its own costs unless otherwise ordered.

6. Limitation of Liability

Membership provides access to networking and promotional opportunities only and **does not guarantee leads or income**.

Members act independently; The Renovation Room is not liable for business losses, disputes, or damages resulting from member interactions.

7. Media Release

By joining, Member grants The Renovation Room permission to use the Member's name, business name, logo, images, and submitted content for marketing and promotional purposes, in print or digital form, without

compensation.

8. Waiver of Liability & Chargeback Protection

Member agrees not to dispute or charge back any membership payments after benefits have been accessed.

This Agreement shall be governed by and construed in accordance with the laws of the **State of Illinois**.
